Anita has been a certified court reporter since 1974, serving as an official in the Los Angeles municipal and superior courts for over 17 years and as a freelancer since 1992. Teaching at court reporting night schools for about 12 years fulfilled her love of teaching. In 1991, she was instrumental in creating the first complete CIC courtroom in the state of California, including video synchronization, wherein she reported backto-back realtime dailies with her partner for a year-and-a-half, networked to 11 computers. Anita went through the process of transforming her own writing skills and gave numerous presentations and trainings to fellow court reporters for two years. In 1992, she combined her experiences and expertise with extensive realtime theory research and created her own company, Anita Paul Realtime Seminars and Workshops, a subsidiary of Anita Paul International. Her training company presents inspirational and content-driven realtime workshops, seminars, keynotes, peak performance strategies, and attorney presentations worldwide, including almost every state in America, England, British Isles, Australia, New Zealand, South Africa, Mexico, Canada, Hong Kong, Trinidad, the Bahamas, and the Virgin Islands. Anita has successfully presented at numerous NCRA and state conventions, and has done extensive trainings for local, statewide and national, and international government agencies. He was an instructor at NCRA Legislative Boot Camp, and has presented several legislative-related seminars for state court reporter associations.
