Drug Courts are built upon a unique partnership between the criminal justice system and drug treatment community, one that structures treatment intervention around the authority and personal involvement of a Drug Court Judge. Drug Courts are also dependent upon the creation of a non-adversarial courtroom atmosphere where a judge and a dedicated team of court officers and staff work together toward a common goal of breaking the cycle of drug/alcohol abuse and criminal behavior.

With his quick wit and enamorous speaking ability, be prepared to hear how Judge Hammer's dynamic personality crosses over into his drug treatment court assignment.

Depending on our unique dispositions, we all handle this aspect of our profession in different ways.

Art and court reporting seems disparate at first blush, but for me they go hand-in-hand. Since the mid-'90s and a string of intense cases, I have been hypersensitive to violence. It's taken me two decades to recognize the legitimacy of the effects of second-hand trauma, the emotional toll of silently absorbing sometimes inhumane stories. Painting was my medicine. I paint to heal myself. I paint to have a voice in the

world. I paint to infuse beauty, shed light on ancient cultures, and memorialize that history for others to learn from. That is how I transform what I have come to recognize as second-hand trauma. By acknowledging how these hard stories affect me, and addressing it in a positive way, I am able to embrace and more fully enjoy the honor of court reporting.
